#### 3.0 Welcome and Opening Remarks

#### 4.0 Police Matters:

Police attended and provided the following crime report in respect of the month of November 2014: 6 reported crimes including; 1 theft; 3 vandalism; 1 fire raising (CCTV evidence at Inverkip Boat Club); 1 anti-social behaviour. A road incident involving 3 vehicles and parking issues at Inverkip Primary School were discussed. Letters have been once again been issued to the parents of school pupils, the area is patrolled and parking tickets have been issued. It was confirmed that parking on the road opposite the lined section of the road opposite Wemyss Bay Primary could be classed as dangerous causing an obstruction. Residents were reminded to call to report incidents.
